CAPTAIN POLYPLAST LIMITED ("the Company") vide, resolution passed by its Board of Directors at their meeting held on Friday, April 14, 2023, appointed Mr. Kishor Dudhatra (Membership No. FCS 7236 and COP No. 3959), Practicing Company Secretary, Ahmedabad as the Scrutinizer to ensure that the process of Postal Ballot is conducted in the manner prescribed under Section 108 and Section 110 of the Companies Act, 2013 ("the Act) read with Rule 20 and Rule 22 of Companies (Management and Administration) Rules, 2014 (as amended).

As per the MCA Circulars, physical copies of the Notice, postal ballot forms and pre-paid business Reply Envelopes were not dispatched to the members for this Postal Ballot. Accordingly, the communication for the assent or dissent of the Members took place through remote e-voting system only.

The Company has published an advertisement on April 21, 2023 in Financial Express, an English Newspaper and in Financial Express, Gujarati newspaper regarding completion of dispatch of Notice of Postal Ballot on Wednesday, April 19, 2023 and also specifying therein the matters prescribed in the rules with regard to e-voting.

The Company has appointed NSDL for facilitating e-Voting to enable the members to cast their votes electronically (herein referred to as "Remote e-Voting"). Members whose names appeared on the Register of Members/ List of Beneficial Owners as on the close of business hours on Friday, 21st April, 2023 ("Cut-off date") were considered for the purpose of Remote e- Voting. The Remote e-Voting period commenced on Monday, 24th April, 2023 (9.00 a.m.) IST and ended on Tuesday, 23th May, 2023 (5.00 p.m.) IST. The votes cast by the members electronically were unblocked 05:16 PM on 23th May, 2023.

Thereafter, the votes cast by the members under the Remote e-Voting facility were unblocked and dpwnloaded from the e-voting website <a href="https://www.evoting.nsdl.com/">https://www.evoting.nsdl.com/</a> in the presence of two witnesses who were not in employment of the Company.
