# Captain Polyplast Ltd records 62% QoQ growth in Q4 FY21 with Revenues of INR 643 Mn

June 15, 2021: Captain Polyplast Ltd. (BSE: 536974), a micro irrigation system manufacturer announces its results for the fourth quarter and financial year ended 2020-21.

#### **Key Operational Highlights:**

- Growth in micro irrigation business driven by seasonally strong demand from Gujarat, Maharashtra & Rajasthan compared to previous year which was impacted by lockdown.
- Availability of subsidy budgets in most of the northern states during the quarter resulted in increased demand. This helped offset decline in southern states, especially Tamil Nadu which was impacted by state elections.
- Capacity Expansion at Kurnool plant is completed with addition of 2 PVC lines and 1 HDPE/Sprinkler line
- Dividend announced at INR 4p/share or 2% of face value

#### **Management Comments:**

Commenting on results, Mr. Ramesh Khichadia, Chairman and Managing Director, remarked, "We are pleased to report that the company has recorded its highest quarterly revenue in its history during this quarter. The strong demand for micro irrigation products in majority of states during a seasonally strong quarter aided the strong growth. The government has allocated INR 10,000 crores for micro irrigation in the FY22 budget which is nearly double of the fund allocated in previous years with the aim of covering 10 Mn hectares in the next 5 years. We expect our core business of micro irrigation to benefit from this development in the coming financial year. During Q4, we have expanded manufacturing capacity at Kurnool due to strong sales of PVC pipes we achieved in the southern states. The additional capacity would help us expand the retail pipes distribution network in these states. We have also increased our focus on the fast growing solar EPC segment during this year which is expected to further aid our topline growth."
