  Trading and Code of Corporate Disclosure Practices' along with a summary on do's and don'ts
  pertaining to Insider Trading issues.

  - Initial Meeting with the Managing Director and CEO, the Executive Directors
  - Meeting with the Heads of Marketing, Sales and Distribution, Human Resources, Legal and Secretarial, Factories and manufacturing units
  - These meeting will cover detailed functional aspects of the Business
  - Visit to manufacturing locations at shaper
- 3. **Post Joining the Board** directors required to attend quarterly board meetings held to consider financial results , a detailed Board Report is circulated to all directors which cover the following
